General Instructions/Conditions:

1. Eligible candidates have to apply through "Online Application Portal (OAP)" of the Ministry of Ports, Shipping and Waterways (<https://onlinevacancy.shipmin.nic.in>)

While applying for the post, the applicant should ensure that he/she fulfills the eligibility and other norms mentioned above. In case, it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and /or that he/she has furnished any incorrect/false information or has suppressed any material fact(s), his/her candidature will stand automatically cancelled. If any of the above shortcoming(s) is/are detected even after appointment, his/her services are liable to be terminated without any notice.

2. All qualifications should be recognized and approved in India by the appropriate Statutory Authority/ Competent Authority.

3. The mere fact that a candidate has submitted the application against the advertisement would not bestow upon him/her the right to be called for interview/considered for selection process.

4. Employees working in Central/State Government/Semi-Govt. Autonomous Bodies/CPSEs must apply through proper channel and submit No Objection Certificate at the time of interview.

5. The crucial date for determining the qualification, experience and age shall be **31.08.2026**.

6. Vacancy advertised can be cancelled at the discretion of Cochin Port Authority without assigning any reasons thereof.

7. Cochin Port Authority reserves the right to shortlist, restrict the number of candidates for personal interview on the basis of qualification & experience by adopting appropriate selection criteria.

8. Canvassing in any form will disqualify the candidate(s).

9. The Applications which are received after due date will not be considered.

10. Candidate must furnish an undertaking in the attached format (Annexure-I) not to withdraw his/her candidature, if selected. Officials, who withdraws his/her candidature for the Post after his/her selection by the Services Selection Committee, will be liable for debarment from future selection to HOD level posts in all Major Port Authority for a period of two years.

The application shall be submitted only through "Online Application Portal (OAP)" of the Ministry of Ports, Shipping and Waterways, followed by submission of print out of application as under :

(a) Eligible and willing officers are requested to apply in the "Online Application Portal (OAP)" of the Ministry of Ports, Shipping and Waterways (<https://onlinevacancy.shipmin.nic.in>) upto **31.08.2026**. The applicant has to register in the Online Application Portal. No application other than OAP shall be accepted.
